ASSIGNMENT OF RIGHTS AUTHORIZATION AND DIRECTION TO PAY

I hereby authorize repair work to be done per the Hampden Auto Body Co, Inc. estimate or the insurance estimate whichever applies, along with the necessary materials or the substitution thereof, should you deem it necessary to expedite completion. I further agree that if any obligation for said repairs, parts or other materials is not paid when due, or suit is brought for payment. I shall be responsible for and shall pay all reasonable costs of collection, including attorney fees, court costs, and interest as provided by law. I understand that I am responsible for full settlement before Hampden Auto Body Co, Inc. can release the vehicle. (If insurance is involved, check with Hampden Auto Body Co, Inc. 's business office first to see if Hampden Auto Body Co, Inc. has received payment(s) and what balance is due). An express mechanic's lien is acknowledged on above vehicle to secure the amount of repairs thereto. I agree to pay a 20% parts restocking fee for parts ordered and later returned (This only applies if I have authorized Hampden Auto Body Co, Inc. to repair my vehicle, then later cancel the order or parts are deemed non-returnable). Parts are considered ordered upon my approval to start work. Parts price increases are beyond the control of Hampden Auto Body Co, Inc. and I am expected to pay these increases at the time of delivery. I also agree to pay an inspection fee if my vehicle is estimated and not repaired. You and your employees may operate the above vehicle for the purpose of testing and/or inspection and/or repair. You will not be held responsible for articles left in vehicle or any other damage caused by any reason which is beyond Hampden Auto Body Co, Inc.'s control. I agree that if my vehicle is not repaired and/or the services are not rendered 3 days after completion and notification storage fees and rates will apply based on the fee structure on display in our front office and this agreement. I further certify that I have read the entirety of this agreement and that I understand each of its provisions.
